Saturday, 13-yearold Christopher Millerick of Southington will be among the competitors. Dipollina said he has been giving him regular lessons and that he is a "good friends with the family."

"I'm really looking forward to The tournament, expected to the tournament," said Christopher. "I go out and golf whenever I have the chance and I've been doing lessons with John for about a year. He has really helped me to improve a lot. I recently got a hole-in-one at Hawk's Landing. I was really excited, it felt great."

Dipollina said junior golfers competed last week at Goodwin Park in Hartford and that the next stop after North Ridge on the tour is Agawam Municipal Golf Course in Massachusetts. Since he became involved with the US Kids Golf Tour, Dipollina said it has been growing in popularity.

"This is the biggest event that the Hartford tour has hosted so far," he said. "When I first started running it we had 50 to 60 kids. to Now those numbers have doubled.
